### WAIVER AND RELEASE OF LIABILITY

In consideration of the Player identified above (the "Player") being allowed to participate in any way in the Faith First, Inc. dba Extreme Fitness Club football program and related events and activities (the "Activities"), the undersigned hereby:

1. Agrees that prior to any Activity, he or she will inspect the facilities and equipment to be used by the Player, and if at any time, believes that anything is unsafe, he or she will immediately advise the officials, coach or supervisor of such and instruct the Player not to participate in the Activity.
2. Agrees he or she will instruct the Player prior to any Activity to inspect the facilities and equipment to be used by the Player, and if at any time, believes that anything is unsafe, to immediately advise the officials, coach or supervisor of such and not to participate in the Activity.
3. Acknowledges and agrees that the Player may be engaged in Activities that may involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from the Player's own actions, inactions or negligence, but also from the action, inaction or negligence of others, the rules of play, or the condition of the premises and equipment, and other factors.
4. Assumes all of the foregoing risks and accepts personal responsibility for damages resulting from such injury, disability, death, or other loss, whether known or unknown, whether caused by the negligence of the Releasees (defined below) or otherwise.
5. Releases, indemnifies, and holds harmless the Releasees from and against any and all claims, causes of action and damages, relief, liability, costs, expenses, fees, demands, injuries, losses, punitive damages, general damages, whether at law or in equity, known or unknown, in connection with or relating to the undersigned's or the Player's

participation in any Activity, including without limitation damage to property, serious bodily injury, or death, whether suffered by the undersigned, the Player, or any person claiming by or through the undersigned, the Player, whether caused in whole or in part by the actions, inactions or negligence of the Releasees or otherwise.

6. Warrants and represents that the Player is, and will be, adequately insured against injury, disability, death and other loss throughout the Player's participation in the Activities; and waives all rights of subrogation against the Releasees.

As used in this document, "Releasees" means Faith First, Inc. dba Extreme Fitness Club, its affiliated organizations, sponsors, donors, advertisers, promoters, officials and referees, owners and lessors of premises used to conduct events, and any and all of their respective directors, officers, administrators, employees, independent contractors, agents, members and owners.
